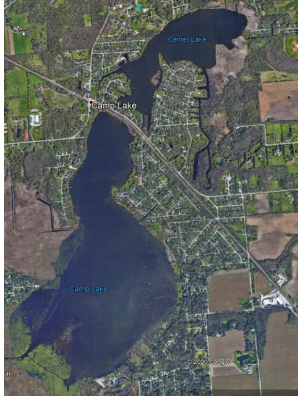
State Statutes & CCLRD Bylaws

Our by-laws require consideration & approval of last year's minutes which are attached to this newsletter. State statutes require a vote on the 2026 budget, which is also enclosed. Approval of the budget is required to remain in compliance with state law. Many projects are multi-year. You can follow our progress by reading the enclosed minutes.

Shoreline Restoration

Our cost sharing program is available for erosion control projects. Approved projects receive up to 50% cost sharing up to \$5,000. Funding is limited and project feasibility is reviewed on an individual basis; for information, email treasurer@cclrd.org.

Invasive Species



Curly-leaf pondweed can interfere with recreational and other uses of lakes by producing dense mats at the water's surface, negatively impacting native aquatic plants and impeding navigation.

Boating Regulations

Boating on Camp Lake and Center Lake is subject to the Village of Salem Lakes ordinances and Chapter 30 of the Wisconsin State Statutes. Highlights of those regulations are posted at every launch and briefly summarized as follows:

- **Camp Lake No Wake:** Sunset to 10:00 a.m.
- **Center Lake No Wake:** Sunset to 10:00 a.m.
- No anchoring in traffic lanes
- Picnicking, swimming, camping, fires are prohibited in launch areas.
- Waterskiing and tubing counterclockwise in traffic lanes only.
- Observe no-wake buoys at all times.
- It is recommended that all boaters wear PFDs at all times.
- No boating in designated swimming areas

Public Trust Doctrine

The Public Trust Doctrine is the basis for the legal rule that all navigable waters are "common highways and forever free." The owners of land on lakes and rivers are "riparian owners" who have some rights to the waters they border, such as the right to erect and use a private pier. However, the Wisconsin Supreme Court has ruled that, in general, the public's rights to use our lakes and rivers are primary and the riparian owners' rights are secondary. These rights include access.

2026 Annual Budget

The Wisconsin State Statute 33.30 require a vote on the budget (copy enclosed), which will be presented by Charles Walker. The line items are categorized so that they are easy to understand.

Approval of the budget is required in order to remain in compliance with state law.

Herbicide Update

The 2025 herbicide treatment program has been successful on Camp and Center Lakes. We weed-scouted the lakes in early spring.

Curly leaf pondweed was choking the channels. This year we treated this invasive weed with Aquathol in the channels. We had many positive comments about navigation improvements.

Camp Lake's milfoil did not rise to the level of whole-lake treatment. We spot-treated

on both lakes as allowed by the DNR for this invasive weed.

All treatments were done with appropriate DNR permits and disbursed by licensed professionals.

2025 Harvesting Report

Harvesting started a week earlier than normal because Curley Leaf Pondweed was prevalent in the channels on both lakes. We focus on channels early in the season, while the water is relatively high.

On Camp Lake, we clear a main path (we call it I-94) from the DNR boat landing to deep water in the North Bay.

After fish spawn, harvesting is conducted according to our Aquatic Plant Management Plan, which can be found at www.cclrd.org/Bylaws and Documents. In the Plan, see page 148, figure 41 “Camp Lake Harvest Priorities”, and page 149, figure 42 “Camp Lake Harvesting Areas”.

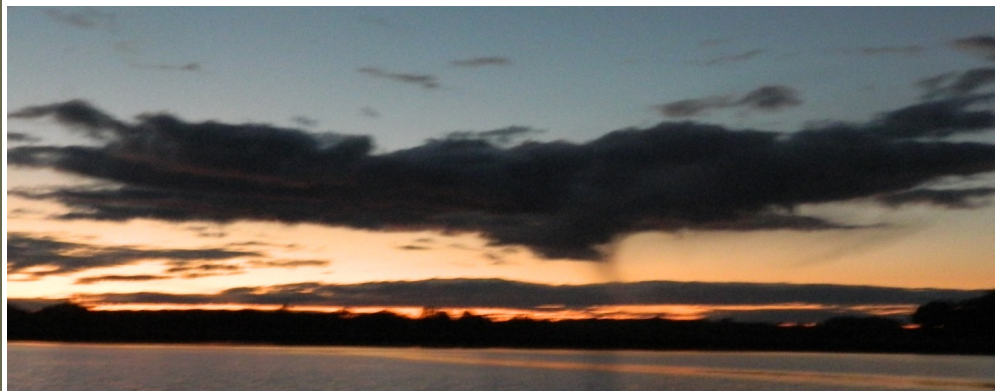


Trees sometimes fall
