## Boating Regulations

Boating on Camp Lake and Center Lake is subject to Chapter 20 of the Town of Salem ordinances and Chapter 30 of the Wisconsin State statutes.

Highlights of those regulations are posted at every launch and briefly summarized as follows:

- No wake from 7:00 pm to 10:00 am
- No picnicking, no camping, and no fires in launch areas

- Waterskiing and tubing counterclockwise in traffic lanes only
- No wake within 200 feet of shore
- It is recommended that all boaters wear PFDs at all times
- Avoid power launching



## Public Trust Doctrine

The Public Trust Doctrine is the basis for the legal rule that all navigable waters are “common highways and forever free”. The owners of land on lakes and rivers are “riparian owners”, who have some rights to the waters they border, such as the right to erect and use a private pier. However, the Wisconsin Supreme Court has ruled that in general, the public’s rights to use our lakes and rivers are primary and the riparian owners’ rights are secondary. These rights include access.

## 2010 Annual Budget

## Thank You!

Thank you - to The Wisconsin Association of Lakes, which CCLRD is a member, for their years of advocacy work and especially in getting the “Clean Lakes” bill signed into law on April 14th. The law prohibits the display, sale, and use of lawn fertilizer containing phosphorus or phosphate which enhances weed growth and provides the nutrient to feed the floating “Duck Weed” in our channels.



## Erosion & Shoreline Protection

Over the last year CCLRD, in conjunction with lake associations, has completed the two most common shoreline erosion applications, the riprap and fiber rolls. The riprap was completed on the public beach in Center Lake Woods. Riprap is a blanket of appropriately sized stones, fitted to the slope and shape of the shoreline, extending from the toe of the slope to a height needed for long term durability. Riprap is flexible and not impaired by slight move-

ment from settlement.

The 2nd erosion control, fiber roll, was completed at the public beach in Camp Lake Oaks. Fiber roles are cylindrical tubes composed of coconut husk or excelsior fibers bound together with coconut or jute twine, or plastic netting. The fiber roll product protects the bank by stabilizing the toe of the slope and by trapping sediment from the sloughing bank. Cuttings and herbaceous riparian plants

are planted into and behind the coiled fiber rolls. The roll decomposes after 6 to 10 years, and the riparian vegetation will stabilize the lakeshore.

If you are concerned with your shoreline erosion, feel free to drive by and view the projects at Center Lake Woods and Camp Lake Oaks beach areas.

## The 45 Minute Flash Flood

June 19th delivered us a flash flood of very newsworthy proportions. Long time residents could not recall a flash flood as spectacular. A downpour lasting only 45 minutes affected almost all residents!

The extreme water volume has sparked an interest in all the policies and procedures and general information about the "check valves" on our lakes. Visits were made to the Camp Lake and Center Lake Dams on a regular basis. Instead of changing the Center Lake Dam,

and reducing the spillway affect that was naturally occurring in Center Lake, the gate was left as it was. This allowed the water to spill over the gate and gate wings and created a 30ft span for the water. Changes to the gate would have reduced that span by at least 10ft. In the end, Center Lake reached a "below flood level" earlier than Camp Lake which did not reach below level until July 5th. Saturation of this magnitude has affected our shorelines. Once you lose the shoreline it

is nearly impossible to reclaim what is lost. That's why adherence to the "SLOW NO WAKE" is so very important to us all.

## HARVESTING REPORT

The winter of 2008 –09 was severe with ice forming early and lasting long, abundant snow cover caused concern for oxygen depletion as our lakes vegetation died. Predicting how this would effect vegetation growth in 2009 had many believing our lakes would be void of any substantial growth of Eurasian Water Milfoil or any other aquatic species as has happened in the past with simi-

lar winter conditions. Mother Nature once again taught us that those predictions and history could be wrong because as soon as the ice left the lakes predominant temperatures were favorable for Milfoil to grow. On Camp the north bay and the south lake proper were showing abundant patches of growth early and the same was evident on Center's north and south bays. When herbicide treatment occurred May 20th those conditions had

## Herbicide Update

The 2009 treatment of Eurasian Water Milfoil was completed on May 20th. The current sponsored cost-shared method for EWM treatment is a granular form of 24-D which is applied at the maximum rate allowed by the State. This year the Board expanded its research of the liquid form of 24-D from 35 acres to 50 acres for both Camp and Center Lakes.


