### **Boating Regulations**

Boating on Camp Lake and Center Lake is subject to the Town of Salem ordinances and Chapter 30 of the Wisconsin State Statutes.

Highlights of those regulations are posted at every launch and briefly summarized as follows:

- Camp Lake No Wake: Sunset to 10:00 a.m.
- Center Lake No Wake:
   7:00 p.m. to 10:00 a.m.

 No picnicking, no camping, and no fires in launch

areas.

- Waterskiing and tubing counterclockwise in traffic lanes only.
- No wake within 200 feet of shore.
- It is recommended that all boaters wear PFDs at all times.
- Avoid power launching.

#### **Public Trust**

The Public Trust Doctrine is the basis for the legal rule that all navigable waters are "common highways and forever free." The owners of land on lakes and rivers are "riparian owners" who have some rights to the waters they border, such as the right to erect and use a private pier. However, the Wisconsin Supreme Court has ruled that, in general, the public's rights to use our lakes and rivers are primary and the riparian owners' rights are secondary. These rights include access.

# Town of Salem Water Patrol

It has come to the attention of the Board that there are a few residents who have questions or concerns with regard to the Water Patrol on Camp/Center Lakes.

#### **2014 Annual Budget**

The Wisconsin State Statutes require a vote on the budget (copy enclosed), which will be presented by Charles Walker. The line items are categorized so that they are easy to understand.

Approval of the budget is required in order to remain in compliance with state law and to continue to receive grants for harvesting machinery and other projects that improve our lakes.

#### **Herbicide Update**

2014 has proven to be yet another successful year for herbicide treatments on Camp and Center Lakes. I weedscouted the lakes in early April only to discover, despite the harsh winter, both lakes were infested with Eurasian Watermilfoil (EWM).

We treated the lakes on May 20th and 21st utilizing 2,4-D. Approximately 73 acres were treated on Camp Lake and 26 acres on Center Lake. The cost was slightly higher in years past due to the lakes being deeper and thus requiring more product of 2,4-D to reach the same

concentration. I have since weed-scouted the lakes and found minimal EWM on Center and EWM on Camp in the far south end where 2,4-D was not used.

Enrollments in the shoreline cost share program are stable and are reporting many new participants. Thanks to everyone for your continued support of this piece of the District's overall management

## **2014 Harvesting Report**

We have been mechanically harvesting since 1996, and over those 18 years much has been learned. One of the most unusual things learned is the apparent fact that it's impossible to predict from one year to the next what aquatic plant species will dominate in what particular areas of our lakes

Certainly we know where Eurasian Milfoil and other species, both natural and invasive, have a history of growing, but it has proven to be impossible to predict when these growths will occur. For example, in 2011,

Eurasian Milfoil (an invasive, bad weed) harvest loads were down 69 percent over 2010 and Widgeon Grass (a natural, good weed) harvest loads were up 149 percent. It appeared that the good stuff was taking over the bad stuff

This trend continued in 2012 with slight variations. However, in 2013, the Widgeon Grass virtually disappeared as harvest loads went down 76 percent and Eurasian Milfoil went up 40 percent. But even that is fooling as the dominate species in 2013 was Eelgrass. Go figure. Eelgrass is consid-

ered one of the best vegetation lakes can have for fish and wildlife. It is highly sought after even though, in late July and August, the female plant grows a little curlicue to the surface and then sprouts a flower which triggers the male plant to wiggle its roots out of the lake bottom and cause it to bump into the female flower and pollinate it. This happens every year, but last year these male plants were floating all over our lakes and accumulating in great quantity on the shoreline. They are easy to recognize because the roots are still attached and the stem is about one-half inch wide, up to two feet long and



Yellowish-green in color.

Judging from this phenomenon, one would think Eelgrass would have a substantial presence this year in our lakes, but that is not the case. One would also think that the severe winter we had with ice and snow cover forming around Thanksgiving and lasting until the end of March would also have a dramatic effect and reduce plant growth in 2014. But again, not so.

What happened? It's difficult to predict, but possibly the nutrients

from the decaying vegetation and melting ice and snow contributed by washing into our lakes, plus the above average rain and cold weather this spring allowed some plants to flourish. Eurasian Milfoil grows in colder water than native species plants do so these conditions were just right for this species to get a head start, and its canopy blocked sunlight that the warmer water native plants need to grow.

The end result is this year we have Eurasian Milfoil growing in greater quantity than we have had in years. The good news is that Center Lake does not have this severe bloom of Eurasian Milfoil and our chemical treatment was very successful in controlling the invasive weed growth in shore areas in both lakes.

Once again we are providing a truck at Yaws Boat Landing for depositing lake weeds. If anyone would like a load of this nutrient-rich and fertile vegetation for their garden just contact me.
