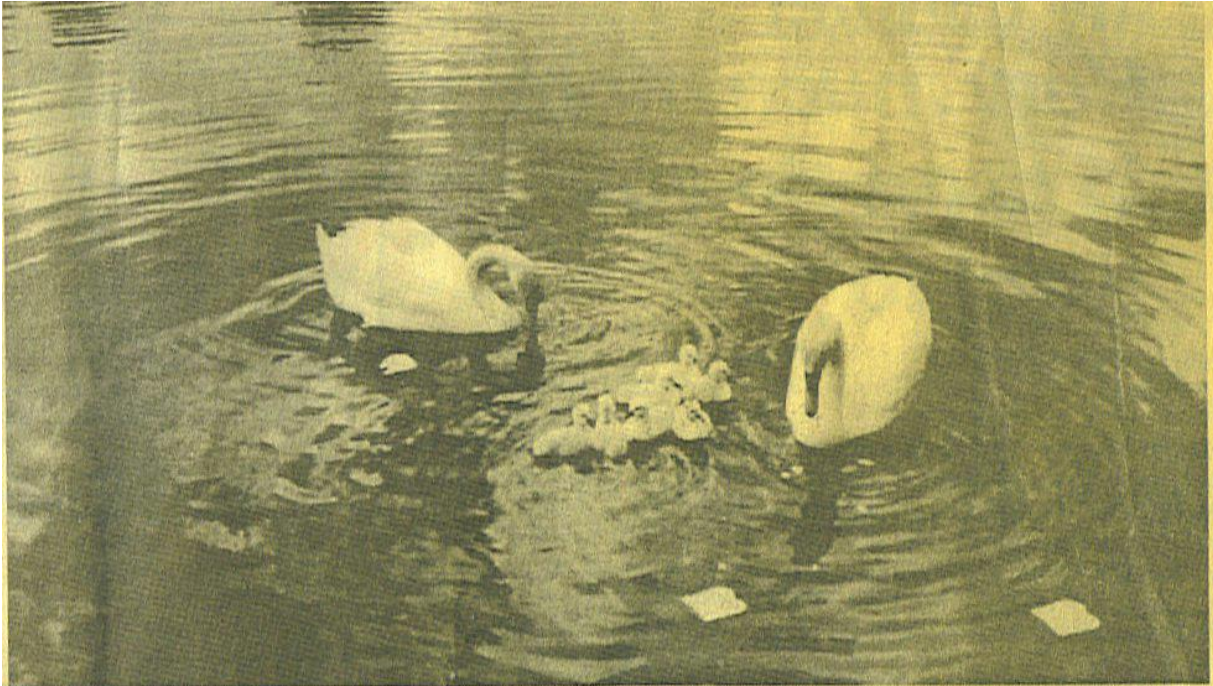

# Beetles come to conquer intruders

## Insects to take on purple loosestrife

SALEM — There are 15,000 more beetles on Kenosha County's Camp Lake and Center Lake today than there were three days ago.

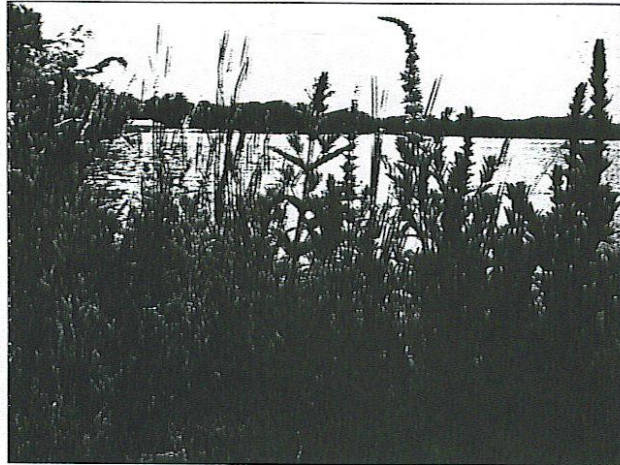
The insect invasion is no accident. These tiny critters have been transported to the area by some nature-loving folks intent on controlling noxious weeds in an environmentally friendly way.

"It's a great way to control a nasty problem," State Sen. Robert Wirth (D-Kenosha) said. "I think it's an exciting project."

Wirth was instrumental in bringing 5,000 *Galerucella* beetles to Center Lake. He had been fishing last year with Thomas Radmer, who owns a house on the lake. As the afternoon was winding down, Radmer mentioned his concerns about purple loosestrife invading the lake.

It seems those beautiful spikes of fuchsia flowers decorating lakes and wetlands are pretty pesky intruders. Introduced to the United States from Europe about a century ago, loosestrife has no natural enemies in this state. The weed has infiltrated more than 40,000 acres of Wisconsin wetlands, according to the Department of Natural Resources, and it will continue invading the habitats of native plants unless something is done to stop it.

That's where the beetles come in. Because cutting, pulling, flooding and herbicide treatments don't seem to work without considerable damage to the environment, scientists sought to find a biologically friendly weapon in the war against loosestrife. It seems the *Galeru-*

cella beetle loves to munch on the stuff. Another plus: these beetles thrive in Wisconsin.

On Thursday, DNR representatives brought five free bags of the creatures (1,000 per bag) to Center Lake. Wirth had contacted the DNR. Radmer helped release the insects.

"What a wonderful surprise it was to get the beetles," Radmer said. "If this works it would be great."

Unknown to Radmer, there were some other biological techies out on Center Lake and Camp Lake Thursday. The Camp Lake/Center Lake Rehabilitation District had contracted with an Ohio company to release 10,000 weevils (*euhrychiopsis lecontei*) in hopes they will control Eurasian water milfoil, another pesky plant. These weevils, native to Wisconsin, were harvested in the state, bred by EnviroScience, Inc. in Cuyahoga Falls, Ohio, then transported to Kenosha County.

The critters cost \$1 each, or \$10,000 for the whole slew, plus \$5,000 for labor. David Giza, the rehabilitation district's chair-

man, said the \$15,000 project has the DNR's blessing. About 7,000 weevils were released at Camp Lake, roughly 3,500 on each of two sites. The remaining 3,000 weevils were released at one Center Lake site.

"Hopefully they'll multiply," Giza said. "Our hope is they will do well, our project will succeed and we'll see positive results."

Giza added that the weevils are not a quick fix to the Eurasian water milfoil problem. It may take a few years before results are noticed.

"It depends on how successful the first colonies of weevils are," he said, noting that EnviroScience will supply additional weevils free of charge if after a few years these don't seem to be doing the trick. Labor will cost extra.

Speaking of labor, Radmer will need some help next year when his loosestrife-attacking beetles are ready to be harvested and spread to new colonies. Area teachers with biology classes looking for some meaningful outdoor ecology studies can contact Radmer at his office at 658-9201.

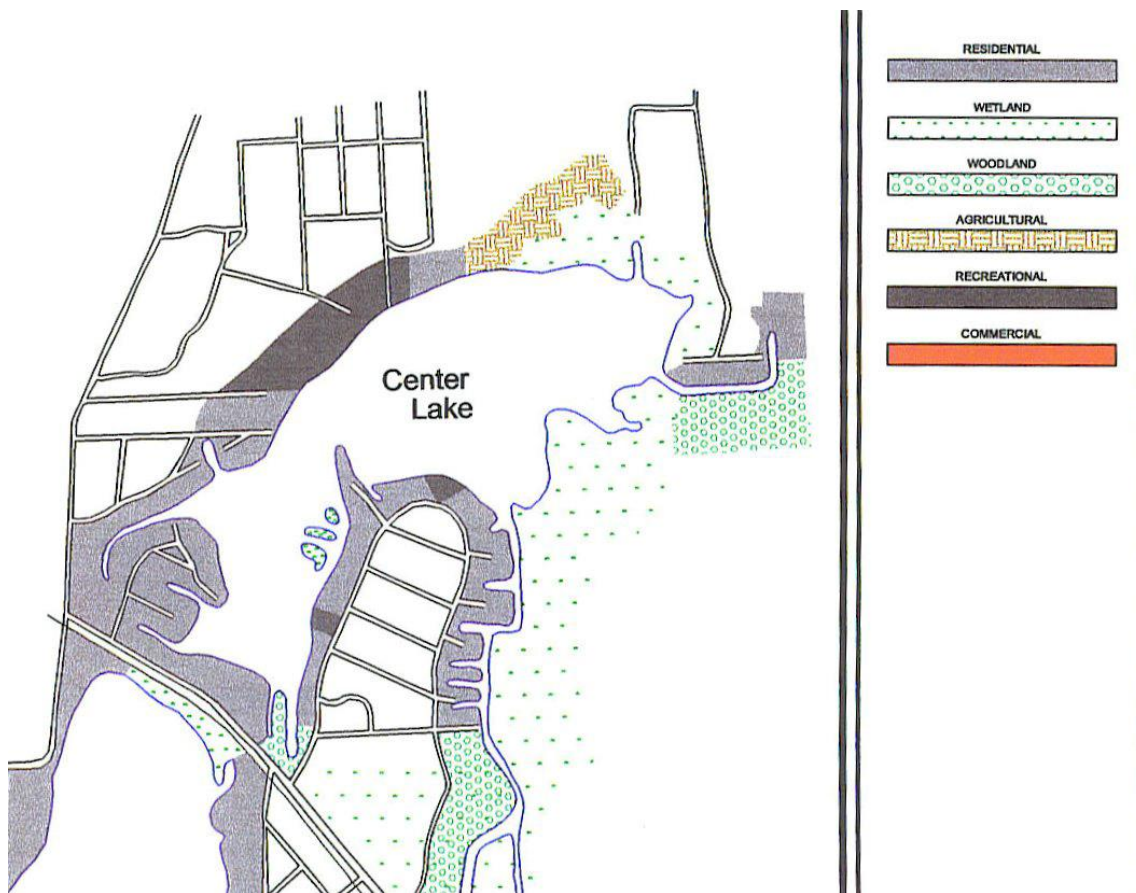

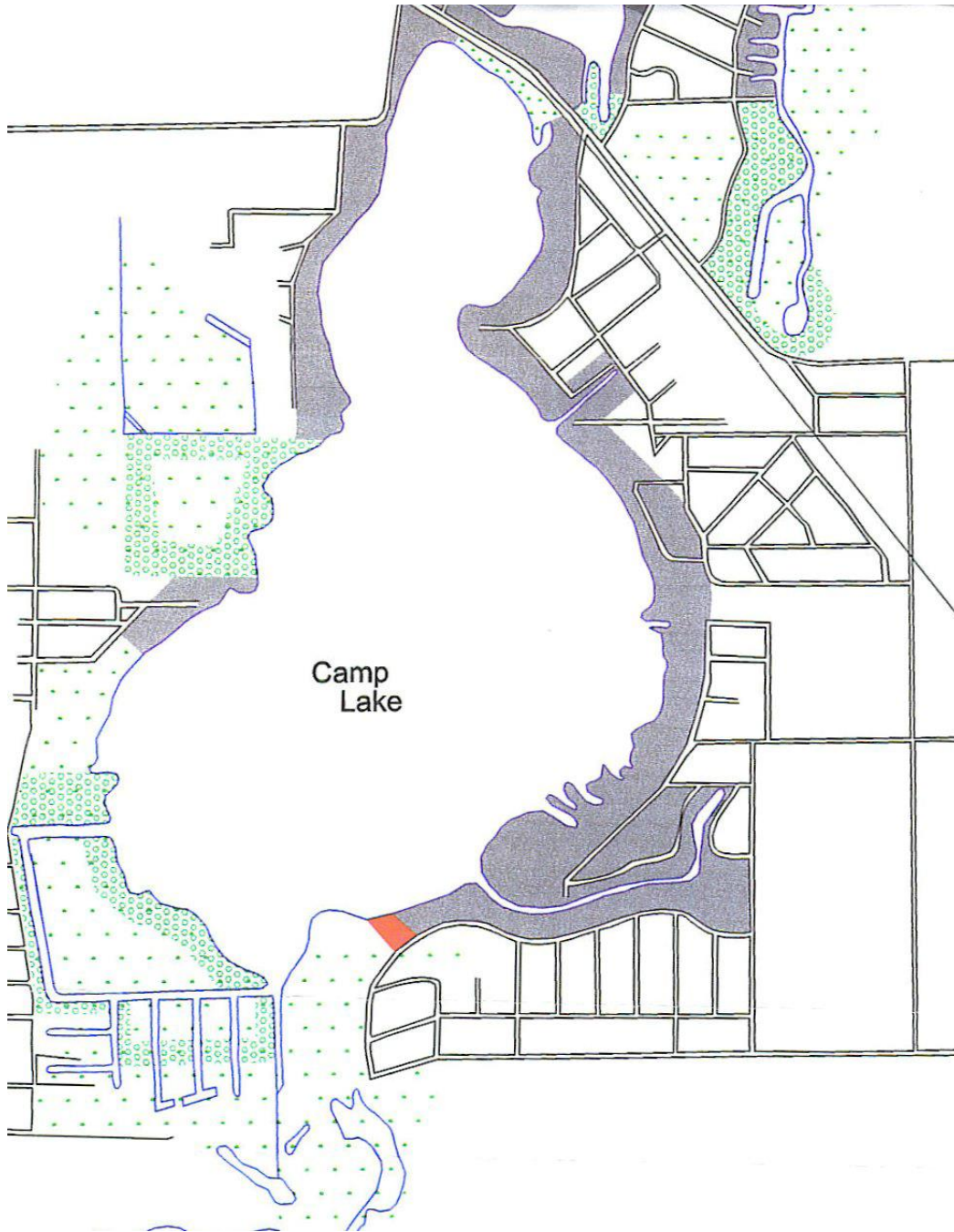

creek from Mark's farm has been repaired by the

Town of Salem and they have also cut the ditch in deeper, and removed trees that had grown; permit to widen the creek and to create a pond on the Mark farm has been rejected because Mr Mark would not allow the 10 soil samples to be taken. The Mark concern is that the creek may have residual from past fires at Badger Cork and the runoff from those may have contaminated the soil; The permit to work and in some places raise 110th (between 269th and 264th) Street and to clean the creek that runs along the north side of the street to Camp Lake has been approved and work will start in the Spring of 2001; The normal high water mark and the wetlands have been marked with flags on the Shoreview lakefront; The next step is to develop a plan for shoreline retention in the different conditions that exist on the length of the property; it was reported that the CCLRD is in process of purchasing a second weed harvester; the CCLRD has been told that the weevils that were purchased and distributed in milfoil areas have failed and the company selling them has suggested it was because of the weed harvesting, a response that the CCLRD is not accepting.

~ 2001 January 8 2001 Three bids have been received for the work anticipated on Shoreview Shoreline (the plans for the specific areas are not yet finalized) - Eagle Springs Environmental \$38,222, Tree and Timber \$44,650 and Crain Landscape \$47,227.49.

~ 2001 January 27 2001 Shoreview plans on a Subdivision meeting on January 27 2001 to update everyone interested in what happened at the CCLRD regarding the lakefront at which CCLRD Chairman Dave Giza and Gerry Hebard of the U S Department

of Agriculture (not the DNR) have agreed to attend; Lakefront Committee is Leann Ahler, Jack LaMeer, Don Lundgren, George Sawicki and Jim Valentine. SIA19982055-8, 9, 10, 16, 36

~ 2001 February 1 2001 CCLRD is writing application to the DNR to participate in the purchase of a second cutter to use in addition to the first cutter and conveyor which were purchased about 10 years ago; The cost for the new cutter, conveyor and new truck will be about \$100,500 and it is being considered that CCLRD lease with the option to purchase; Hey and Associates will prepare the application to the DNR for the shoreline work in Shoreview; Maps and measurements of the Shoreview shoreline to date cost the CCLRD \$2500.00; As a note, The DNR measures the shoreline and SEWERPAC (under the Army Corps of Engineers) measures the Wetlands; Schedule for Shoreview events is: March 31 2001 Vince Mosca and Lakefront committee to walk the lakefront and listen to suggestions about approach to take in the specific areas; April 30 2001, Vince will present plan and estimated REAL dollar figure; May 13 2001 Shoreview Improvement Association will meet to review, approve or change which includes also looking at examples of the work of those who submit proposals; June 1 2001 we will request permits; September 3rd 2001 hopefully permits will be approved; September 10 2001 obtain Quotes for the work to be done; October

1 2001 break ground on the project; It is reported that the oxygen level in the south end of Camp Lake has been measured and found to be minimal; Dave Giza reports that the CCLRD is pursuing restocking of the weevils by Enviro-Science; Jeff Boening submitted a proposal to clean the lakefronts at 480 man hours at \$18.75 per hour and will be completing the removal of the rest of the ICE houses as well as THE OLD BUICK that was in Camp Lake to the east of the Last Resort, two houses from the channel. ~ 2001 March 13 2001 To Dave Giza CCLRD from Jim Valentine Confirmation that the Shoreview home owners voted on September 11 2001 13-0 to proceed with the Shoreview Shoreline Stabilization Project and to obtain confirmation from CCLRD regarding the expected Shoreview contribution to the project in writing and a 10 year maintenance period. ~ 2001 May 23 2001 The Lakefront Walk-thru has happened and Lots 1-5 will have the berm flattened so that the lake can come up and down and will eliminate the holes; Lot 6 will be left as is and some material will be added; Lot 7 will be flattened to remove the berm and will do some plantings; lots 8-11 will leave as is and add rip rap, lots 12 and 13 flatten out the berm, lots 14 thru 16 leave as is but open a



space next to fire lane to allow water to flow in and out; lots 17 thru 19 flatten the berm and allow open flow to the lake, lots 20 thru 22 leave as is but clean up; Weed cutting on Camp Lake will start on June 5 2001 with two machines. DNR agrees to split the cost of the second machine which means that CCLRD will get a return of \$45,000. SIA19982055-33

~ 2001 August 4 2001 Shoreview Improvement Association met and listened to Dave Giza Commissioner of CCLRD and Vince Mosca a consultant working for the CCLRD make their presentations about what they think we can do to preserve the shoreline; Based on the information given at the meeting, the project will cost about \$80,000 and the Association will be responsible for 5-10% of that which is approximately \$6000. We have 240 hours of sweat equity built up which is being valued at about \$1680. SIA has other instances in the future for doing manual work and that we will have to contribute approximately \$2320 in cash to the project; 110th Avenue will be under construction - asphalt paving,

culvert/bridge on 269th over the creek that spills into Camp Lake to replace a metal 6 ft culvert, a slight rise of the 100th avenue pavement and cleaning the creek on the north side where it parallels the roadway; safety rails for the bridge on 267th Avenue over the creek to Camp Lake have been purchased; The Ron Mark Farm project has been approved by the DNR for deepening and widening the creek east of 267th Avenue which will (hopefully) help alleviate flooding; a POND is not included in the project. ~ 2001 August 25 2001 THIRTEENTH ANNUAL CCLRD MEETING held at Salem Community Library, 300 feet of bio-matte material is being installed on Wdowicki property and that another 50 ft project is at the north side of Center Lake at Appelhans property; Jerry Hebard reports that there are 5 completed priority watershed projects in Center Lake and three in Camp Lake and 4 open projects in Camp Lake and 2 open in Center Lake and that for the next 6 years we will be able to spend \$21,468 per year on these projects; There is a plan to stock both lakes with walleye; the attendees vote in a tax of .0007666 per assessed evaluation. ~ 2001 September 14 2001 CCLRD met on August 25 2001 at the Community Library and reports that their goal to reduce runoff of fertilizer and pesticides from farms into our lakes is 38% and they believe that they have reduced it by 68%; two projects are in process on the two lakes, 300 feet of bio-logs are being added to one homeowner property on Camp lake and 50 feet of riprap is being added for a homeowner on Center Lake; Dredging is being investigated and Shirley Boening is in charge of that Committee; Current estimate for the Shoreview Project is \$60,000 to stabilize the shoreline; to date the CCLRD has completed 8 projects on Center Lake and 3 on Camp Lake and 4 are now in process on Camp, 3 on Center; 2000 we paid \$87 per \$100,000 to CCLRD and 2001 it will be \$77 per \$100,000- a reduction! There was discussion regarding boaters requiring a sticker for approved usage of the two lakes which is up since other lakes are charging an access fee; sweat equity for Shoreview workers is based at \$7.00 per hour. 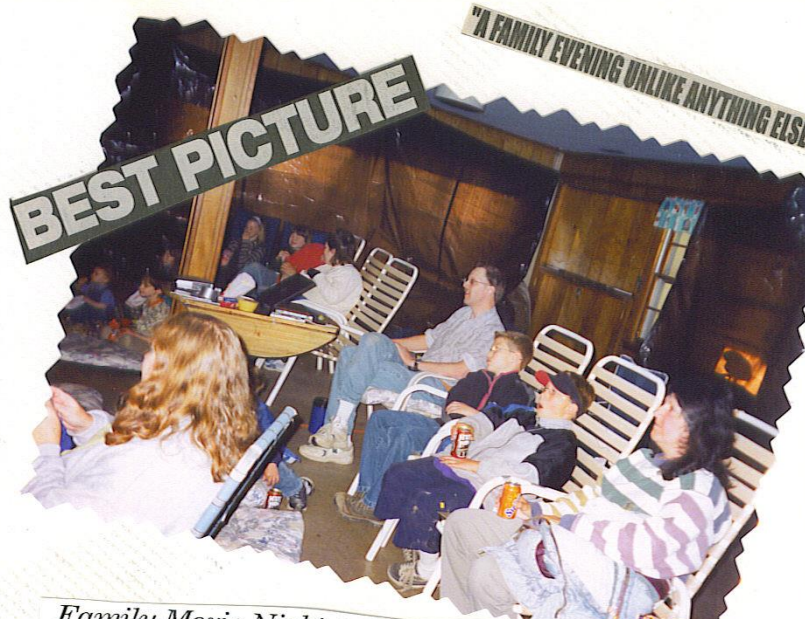

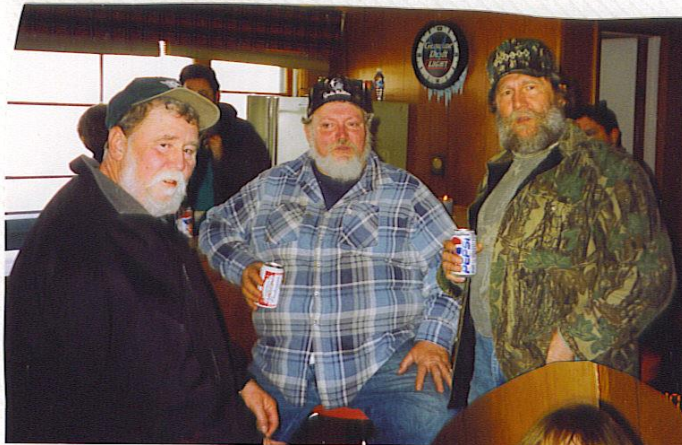
